# MARK WHITING PROJECT SUMMARY AND REPORT [Whiting2011Dec / 1144]

25 January 2012

# OBJECTIVE

Review the client's binders of information regarding past research on William
Whiting, the immigrant who arrived in Massachusetts in 1633 and lived much of
his adult life in Hartford, Connecticut. Analyze the materials and make
recommendations for future research efforts. The goal is to determine the English
origins of the immigrant William Whiting.

# BACKGROUND

Identifying the place of origin for the immigrant ancestor William Whiting has
been the primary objective of research conducted on the Whiting line for at least
the past six decades. A variety of strategies have been employed and many
sources have been searched. Important evidence has been found that identifies
William's occupation, religion, family members, and status in the community in
which he lived as an adult. Leads generated during the research process were
followed up using a combination of original and derivative sources. Amassed
research materials now fill at least four binders. Yet the English origin of William
Whiting still remains a mystery.

# RESULTS

- Created a PAF file for the immigrant ancestor and his immediate family members.
   Recorded important evidence for these individuals, particularly for William Whiting. Please check the PAF notes for more specific information about probate searches, associates of William Whiting, etc.
- Gleaned important evidence about William Whiting that should prove helpful as research continues. This information includes the following items:
  - William was an educated and wealthy man with great influence in Hartford and the Connecticut colony. He held important positions in the colonial government of Connecticut and associated with leading men in politics and religion in New England. William's status in his community

implies that he did not originate from the poorer classes of England. Most likely his parents were also educated and had some wealth and status.

 William was a nonconformist. He migrated from Massachusetts to Connecticut in the company of Thomas Hooker and his followers. Hooker was a nonconformist minister who matriculated from Cambridge, preached in Essex, was censured due to his unorthodox beliefs, left England for Holland in 1630, and migrated to New England from Holland in 1633—the same year William Whiting immigrated. It is possible that William knew Thomas Hooker in England and became a follower at that time. William seems to have been a devoted religious man. He encouraged his son John to join the clergy, which he did. William's nonconformity may have originated with his parents or may have resulted from his association with nonconformist ministers such as Thomas Hooker in his adult years. His nonconformity provides an important clue. His devotion to religious beliefs could have been shared by other family members who joined the clergy. His nonconformity may also have been shared by other family members who left England due to persecution. It is possible that some of his family members may have migrated to Holland, New England,

Barbados, or other parts of the world.

 William left a will and codicils that named his wife Susanna; children William, Samuel, John, Sarah, Mary, and Joseph; and a brother (unnamed) who may have had children. (Note: Susanna was named as William's wife in his will. The reviewed materials did not provide evidence that she was his first and only wife or that Susanna was the mother of all of his children. The only evidence found concerning Susanna was that she was William's wife at the time he wrote his will. No evidence has been found that William married twice—but then no evidence has been found as to when or where he married Susanna either. One undocumented source suggested that Susanna's surname was Wiggens.) William also stated in his initial will dated 1643 that he did not then know if his parents were still alive. As William probably knew the status of his parents when he left England in 1633, it could be assumed that both of his parents were alive as of that year. Therefore, the parents of the ancestral William Whiting were likely alive until at least the early 1630s. Any potential set of parents located for William should meet this expectation. This also indicates that probate records for his parents should be sought after the early 1630s. One item should be kept in mind while examining probate records for William's potential parents. If William's parents did not share his views on religion, they may have cut him out of their wills and he will not be mentioned. Therefore, we cannot have absolute confidence that probate records for his parents will reveal his connection to them. In addition, William had a brother with children in England by 1643.

William arrived in New England in 1633 with Thomas Wiggens who married Catherine Whiting in 1633 in London by license. Catherine is believed to be the sister of William. The marriage license for Thomas and Catherine provided their ages and residences as of that date. According to

this information, Catherine was born about 1601. Both Catherine and Thomas Wiggens were residents of St. Matthew Friday Street parish. Thomas was described as a gentleman and a widower of about 41 years of age. The couple planned to marry at St. Margaret New Fish Street. According to documentation found in the client's notebooks, registers for these parishes do not exist or are incomplete for the early 1600s and so the marriage was not sought in St. Margaret New Fish Street registers. However, the Family History Library Catalog does show that some records for this time period are available for St. Margaret New Fish Street and for St. Magnus the Martyr, which combined with St. Margaret New Fish Street. These records need to be searched. It is assumed that Catherine was not living in that parish alone at the time she married but that she resided with her parents or siblings. Knowing that William Whiting had a sister Catherine born about 1601 is a tremendous clue to his identity. A definitive christening for Catherine has not been found in any database containing extracted parish registers for England. It is quite possible that William and Catherine may have been christened in one of the London parishes whose records have not yet been extracted or searched. It is also quite possible that William and Catherine's christening records, William's marriage to Susanna, and the christening records of William's first few children were recorded in one of the London parishes whose records were destroyed in the fire of 1666. This would explain why his marriage and the christenings of his older children have never been found. This possibility makes it even more important to locate records, such as probate, that would connect William to his parents.

- William Whiting Jr. used a coat of arms on his letters that was very similar to the coat of arms used by Whitings of Boston, Lincolnshire. The similarity highly suggests that both lines descend from a common ancestor. The Whiting coat of arms used by the ancestral family is a huge clue to William's lineage. More research needs to be conducted to follow up on this lead. Heraldic visitations should be searched for multiple counties, published genealogies and pedigrees need to be examined, and a comparison of Whiting coats of arms needs to be made.
- Learned that previous researchers have looked for William in some of the existing records of parishes near where his proposed sister Catherine married, in registers of various parishes in Lincolnshire, and in registers of parishes in a few other locations across England. Nothing definitive was found for William. Any leads that were discovered were pursued. Two locations in England appear to be more promising than others to be William's place of origin—Lincolnshire and Suffolk. Evidence was presented both for and against each of these locations in the collected research materials. Both locations produced Whiting men of prominence who became clergymen or civic leaders. Both areas produced Whiting men who migrated to the New World. Social prominence, interest in religion, and migration were common factors between William and these two clusters of Whitings. (See the PAF notes for William Whiting for more information.) The two shires that are top priorities for future research are Lincolnshire and Suffolk. Shires with

- secondary priority are Middlesex, Leicestershire, Northamptonshire, Essex, Kent, and Norfolk.
- Learned that Whiting men of London who were admitted as freemen to the Fishmonger's Company were studied in the past. At one point, they were thought to be the most likely family members of the ancestral William. It seems incongruent that the ancestral William Whiting who was educated, wealthy, and powerful would be closely tied to the freemen of the Fishmonger's Company of London. However, it would be prudent to search for a will for the Samuel Whiting who was living on New Fish Street in 1638 and was admitted a freeman to the Fishmonger's Company.
- Found that previous searches conducted in probate indexes for several major courts produced leads but no definitive results. Probate searches have definitely not been exhausted and should be continued. There was no indication in the client's provided materials that all of the courts with jurisdiction over Lincolnshire, London, Suffolk, and other areas of interest have been thoroughly searched.
- Determined that the William Whiting who married Susanna Sabin in Canterbury
  was not the ancestor and should be dropped from consideration. This William
  Whiting was christened in Canterbury in 1615. After their marriage, this couple
  christened children in that parish until 1653—long after the ancestral William was
  in Connecticut.
- Conducted some original research.
  - Verified the existence of the Thomas Wiggens-Catherine Whiting marriage allegation.
    - Located two marriages for William and Susan Whiting couples. One couple has been disproven; the other couple requires further investigation.
    - Searched for potential christenings of Catherine Whiting (born about 1601) who had a brother William. The search produced multiple possibilities for Catherine, but none of the candidates had a brother William who survived to adulthood.
    - Checked The Great Migration Begins: Immigrants to New England 1620-1633 but it did not add any new information.
    - Searched the catalog of The National Archives (England) for William Whiting. Located one item of interest in the Chancery class but it related to the family of the William Whiting who married Susanna Sabin in Canterbury. This couple has been disproven as ancestral.
    - ☐ Searched the index to the Prerogative Court of Canterbury and noted many Whiting wills of interest that have not been examined as yet.
      - O Located a christening record for William, son of Francis Whiting, in Croft, Lincolnshire dated 8 March 1600. This Francis Whiting could be the brother of William Whiting of Boston, Lincolnshire who left a will in 1618. This would tie Francis to the Boston Whitings which is significant since the coat of arms used by the ancestral William Whiting was similar to the one used by the Boston Whitings. This Francis did not christen a daughter Catherine in Croft parish. Perhaps he christened a daughter of that name in another parish.

- Located other possible christenings for William Whiting, but none of these men also had a sister named Catherine.
- Located and reviewed an abstract of the will and codicils of William Whiting of Hartford.<sup>1</sup>

## RECOMMENDATIONS

- Search the existing registers of St. Matthew Friday Street parish, St. Margaret New Fish Street parish, and St. Magnus the Martyr parish from 1590 to 1635 for (1) the marriage of Thomas Wiggens and Catherine Whiting, (2) christening records for William Whiting and Catherine Whiting, (3) the marriage of William and Susanna Whiting, and (4) christening records for William and Susanna Whiting's children. The Family History Library has some records for these parishes during the early 1600s. The notebooks indicate that St. Magnus the Martyr registers were searched and did not contains Whiting entries from 1600 to 1622. It is not clear if the marriage records were also searched. The christening registers prior to 1600 need to be examined.
- Locate the 1648 administration for William Whiting referred to in Gordon C. Whiting's book. Apparently Miss M. Packman located the record and reported that William left "any and all" of his English property to his wife. Verify that this is true. Then seek for probate records that dispose of William's property in England. Strive to determine if William's widow or one of her other husbands disposed of the property. Be aware that the property may have been inherited by one of her sons who may have disposed of it. Knowing where the property is in England could reveal William's place of origin. One undocumented source found in the client's notebooks stated that William Jr. sold "the lands" he received from his father to Liborn Nichols of Witham in England.
- Locate the will or administration for the immigrant's son William Whiting Jr.
  who returned to England and lived in London. William Jr. was a merchant and
  served as a representative of the Connecticut colony. He may have left a will or
  administration about 1699/1700.
- Examine works of Burke, Marshall, and other similar genealogical publications
  for Whiting families, particularly those of the East Anglia and London areas. This
  study of English biographical sources has not been made in the past (based on
  information provided in the binders). William's family will likely be included in
  one of these publications since his family used a coat of arms. Determine if a
  William Whiting of "New England" or a William married to a Susanna is
  mentioned in any of these families.
- Track the coat of arms used by William Whiting Jr. (Note: Gordon C. Whiting
  included two drawings of coats of arms used by Whiting families in his book.)
   Compare the coat of arms used by different Whiting families to learn if they all
  likely tie into one common ancestor. Determine the original grantee and track his
  descendants. An investigation into the coat of arms began but was discontinued.

- As Naoma Harker wrote in 1980, "...the search was continued in England, London specifically, but is not to be considered an exhaustive search. It was discontinued about 1967 being very expensive..."
- Check heraldic visitations for at least Lincolnshire, Northamptonshire, Leicestershire, Suffolk, Essex, and Middlesex. It is not evident from the client's materials that this has been done in the past. Learn if William is mentioned or if any of the Whiting lines look more promising than the others. Determine which of these lines had a coat of arms similar to that of the ancestor.
- Search marriage license records for William Whiting's marriage to Susanna (her maiden name may have been Wiggins). The couple likely married in London before 1633 and may have married in a parish for which the parish registers are not extant. Also check the Faculty Office and the Vicar General's Office for marriage license records. If a marriage license record is not found in London, then the search should continue in other primary counties of interest – Lincolnshire, Northamptonshire, Leicestershire, Essex, and Suffolk would top the list.
- Track the William Whiting who married Susan Panckris in Horsham, Sussex on 26 February 1621. Did they remain in that parish? Did they christen sons named William, John, or Samuel in that parish? Could they be the ancestral couple?
  - Search for the William Whiting supposedly born at Boxford, Suffolk; Boxted,
    Essex; or Boxted, Suffolk. Determine if there is a valid christening for William in
    one of these three parishes. If a christening is found, then also determine if this
    William had a sister Catherine. The parish of Hadleigh in Suffolk should also be
    searched as a Whiting family with a coat of arms was located there.
  - Track Thomas Hooker, a nonconformist religious leader of the Puritans with whom William Whiting associated. William left Massachusetts and came to Hartford, Connecticut with Hooker and his followers in 1636. William may have become acquainted with Hooker in London. Hooker preached at Chelmsford St. Mary's Church in Essex for four years before he went to Holland in 1630 and then to New England in 1633.
  - Check chancery court records. Apparently, this has not been done in the past.
    Miss Packman claimed that William Whiting's administration declared that he
    had property in England. Perhaps that property was in dispute at some point.
    Chancery court records have the potential to name one or more generations of
    ancestry.
  - Check probate indexes for the Prerogative Court of York and the Prerogative
    Court of Canterbury. There will likely be many Whiting wills. Begin by
    examining the wills for Whiting testators who lived in Lincolnshire, Middlesex,
    and Suffolk. Then extend the study to men who lived in Leicestershire,
    Northamptonshire, Essex, Kent, and perhaps Norfolk. The provided materials do
    not indicate that indexes to the PCY were ever searched.
  - Check probate indexes for courts at the diocese and archdeaconry levels for Whiting testators who lived in Lincolnshire, Middlesex, and Suffolk. Then extend the study to men who lived in Leicestershire, Northamptonshire, Essex, Kent, and perhaps Norfolk. It is not apparent that a thorough search of these courts has been conducted in the past.

- Track the Francis Whiting who christened several children including a son William in Croft, Lincolnshire. Did he also christen a daughter Catherine about 1601 possibly in another parish? Learn if Francis was a prominent man in the area. He may have been the brother of the William Whiting of Boston who left the 1618 will. Learn if Francis Whiting of Croft left a will. If so, he could have mentioned the whereabouts of his son William.
- Search for a will for the Samuel Whiting who was living on New Fish Street in London in 1638 and was admitted a freeman to the Fishmonger's Company. Learn if he had a son William who was admitted as a freeman in 1621. He is likely the same man who christened 11 children in St. Magnus the Martyr parish. There is a will for a Samuel Whiting, victualler of Upper Shadwell in Middlesex that was probated at the Commissary Court of London in 1642 (Register 28, folio 348v). Examine this will.
- Check Smith's Inventory volumes for at least Lincolnshire, Middlesex, and Suffolk for "Pedigrees: Whiting" to learn if there are sources at the Family History Library that are catalogued in unusual ways.
- Study some of the more promising Whiting men who matriculated from Cambridge to learn if they may be related to the immigrant William Whiting. Examples: (1) A William Whiting matriculated from Cambridge in 1593 and was perhaps the minister of Thurcaston, Leicestershire in 1606, (2) Whitings from Northamptonshire (particularly from Etton) served as priests in Rutlandshire and Northamptonshire (Gordon C. Whiting's book includes Miss Packman's lists of these men), and (3) Samuel Whiting, son of John Whiting of Boston, Lincolnshire, matriculated from Cambridge and later migrated to Massachusetts. Be aware that no connection was found between the immigrant William Whiting and the Whitings who attended Cambridge University in England during previous research. However, more information may be available now than was available a few decades ago.

# CONCLUSION

Much quality research has already been conducted on the Whiting line and has
produced significant clues such as William's status, religious affiliation, and
names of immediate family members. These clues should now be pursued in
additional sources. The first recommended searches involve the coat of arms used
by the immigrant William Whiting. Heraldic visitations, published genealogies
such as Burke's, and publications describing coats of arms used by Englishmen
should all be studied to learn what clues they may contribute to the immigrant
William Whiting's lineage.

[There is a William Whiting of Boston who left a will in 1618. He christened a son William at Boston in 1602. The child christened in 1602 cannot be the emigrant because he would have known that his father was dead when he wrote his will in 1647. However, he could be related. The researcher assumed that the John Whiting who died in 1617 (the father of the emigrant Samuel Whiting) and the William Whiting who died in 1618/9 were brothers. "There was another brother Francis who may have had children and no doubt there were many other Whiting nearly related. The name occurs frequently in Lincolnshire probate courts." Letter dated 18 June 1958.]

Croft and Boston are about 15 miles apart.

- 1. William migrated from England to Cambridge, Massachusetts in 1633 with Thomas Wiggins. Wiggins had been in America before. Another source says that William first came to Cambridge in 1631 and later was an original settler of Hartford (New England Register vol. 103 pg 35).
- 2. An original settler at Hartford in 1636. He came to Hartford with Thomas Hooker, a reverend with the Puritans. Both William Whiting and Thomas Hooker were nonconformists. William was a wealthy merchant dealing with grain from America to England. He had a trading house on the Delaware River and at Westfield and had dealings with Virginia. He owned land in Connecticut and New Hampshire.
- Dep. from Hartford to Connecticut General Court, 1637; a member of the General Court in 1637.
- In 1638 he was allowed to trade with the Indians and in 1642 appointed to collect tribute of the Indians on Long Island and on the mainlands.
- 5. In 1640 William was admitted as a freeman. In 1644 he was listed as a merchant. In 1645 he became the constable in Hartford.
- William served as the second colonial treasurer of Connecticut 1641-1647.
- 7. William was a Major in the colonial forces.
- 8. William served as commissioner of the United Colonies for Connecticut 1646-7.
- 9. William was a leading man in the Connecticut colony and was of a gentleman's status. He was a man of wealth and prominence. His estate at his decease was worth 9000 pounds sterling. He made several trips to England.

10. William made his will on 20 March 1643. Codicils were added on 2 April 1646 and on 24 July 1647. (William amended his wills before his voyages at sea to England.) The codicils indicate he had other children since the making of his original will. The will was recorded on 24 April 1649. William named his children as William, John, Samuel, Sarah, Mary, and Joseph. Joseph was likely born after the initial will was made as he was not mentioned in it; he was provided for in a codicil. William had a "sister Wiggins" who had children. He also gave money to Margery Parker, Mr. Hopkins, Mr. Webster, to the children of Mr. Hooker, to the children of Mr. Stone, to the poor of Hartford, to the town of Hartford, to the poor of Windsor, to the poor of Wethersfield. Mrs. Whiting had the will probated on 2 September 1647. William left money to his father and mother (in his 1643 will) if they were still living, and if not, the money was to go to his brother. The parents and brother were not named. On 29 October 1647 Mrs. Susanna (Whiting) Fitch by an instrument of resignation dated 27 June 1662 resigned her interest in the estate of Mr. William Whiting, deceased. On 5 October 1654, Mr. Webster, Mr. Stone, Mr. Fitch, Mr. William Whiting, Mr. John Whiting, presented to the court a distribution of Mr. Whiting's estate agreed upon by them.

11. William was a man of weath and education, one of the most respectable settlers in 1636 and one of the civil and religious fathers of Connecticut.

He was closely associated with George Wyllys and Thomas Wiggin.

13. Searches made by James Cunningham in England in 1949 - Deptford St. Nicholas, Kent 1592 to 1600 - produced no trace of William Whiting. He did find the marriage of John Whiting and Margaret Bonner on 22 December 1586 in Boston, Lincolnshire. According to the will of this John Whiting, he did not have a son William. The researcher stated that it is possible that the Whiting family was in Boston, Lincoln before the registers began.

14. A researcher located in the Bishop of Lincoln probate court a will dated 21 October 1617 (1617, i, folio 239) for John Whiting the elder of Boston, woollendraper. John named a daughter Margarett, wife of Richard Carter; wife Isabell who receives his house in Boston; son James; son Samuel who was at Cambridge; son John; daughter Awdree, wife of Robert Wright. John is the eldest son. His son James is not yet 23. John marked, not signed, the will. Proved on 31 Oct 1617. Witnessed by William Whiting. No son William or daughter Catherine.

15. A William Whiting of Boston also left a will dated 1618. He christened a son William at Boston in 1602. The child christened in 1602 cannot be the emigrant because he would have known that his father was dead when he wrote his own will in 1643. However, he could be related. William's 1618 will stated that he was a woollen draper of Boston, had a wife Margaret, youngest son Isaac (minor), son Robert, son William, brother Francis Whiting, and cousins John Whiting and Richard Carter. The researcher assumed that the John Whiting who died in 1617 (the father of the emigrant Samuel Whiting) and the William Whiting who died in 1618/9 were brothers. However, William's 1618 will says that John is his cousin. "There was another brother Francis who may have had children and no doubt there were many other Whitings nearly related. The name occurs frequently in Lincolnshire probate courts." (Letter dated 18 June 1958)

16. William Whiting was using a similar coat of arms as John Whiting from Boston, Lincolnshire and John's son, the Reverend Samuel Whiting who migrated to New England and lived at Lynn, Massachusetts. Therefore, there is likely a connection between the ancestral William and these Whiting men of Boston, Lincolnshire. Several letters written by William Jr., his son, are sealed with a coat of arms which are a variation of those used by the family of Whitings of Boston, Lincoln. The coat of arms is described in "Roll of Arms" registered by Committee of Heraldry, New England Historical and Genealogical Society. Major William Whiting, original proprietor of Hartford, liv. 1687 - azure a leopard face gold between two flaunches emine in chief 3 bezants; crest a demi-eagle displayed with two heads proper (New England Register vol. 106 pg. 258). The family's coat or arms were quartered at a Chantry of St. Lawrence at Leake, which is not far from Boston, Lincolnshire. Gordon C. Whiting's book includes a graphic of the coat of arms for Thomas Whiting (1400s) and his descendants in Leicestershire and Essex (page 35). It is very similar to the coat of arms claimed by William Whiting (page 55). See Heraldic Journal, volume 1, pages 61, 160.

17. William was possibly living near his sister Catherine in London at the time she married in 1633 and returned to America with her and her husband in 1633.

 Researcher in England found the Whiting surname popular in St. Magnus the Martyr parish in London. But no Catherine Whiting was listed.

19. A marriage found for a William and Susan Whiting. "William Whiting of St. Mary Magdalene Canterbury, woolendraper, bachelor, 23, son of William Whiting, Alderman of Canterbury, who consents, and Susan Sabin, virgin, 17, dau of Alvert Sabin, Alderman of Canterbury, who also consents. To marry at St. Mary Bredman's Canterbury." William was christened on 2 April 1615 at St. Mary Magdalene, son of William. He had a sister Katherine christened on 19 Sep 1619. But the William and Susan Whiting who married in Canterbury also christened children in Canterbury down to 1653 and cannot, therefore, be the ancestors who were in America by 1633. (Letter dated 18 June 1958)

20. The 1648 will of James Whiting of Boston, woollen draper was examined. He named his wife Mary, son John (minor), son Samuel (minor), brother Samuel Whiting now in New England, sister Wright, brother John Whiting. So he was the son of the John Whiting who wrote the 1617 will.

21. A researcher stated he checked subsidy and assessment lists for London and found a William Whiting living on Thames Street in St. Michael Queenhithe parish in 1638 [but the ancestral William was in New England then]. The researcher thought this could be the ancestor. Another person of interest was Samuel Whiteing of St. Magnus parish which adjoined and was later absorbed with St. Margaret New Fish Street. The registers of St. Michael Queenhithe do not start until October 1653. (Letter dated 27 June 1958) Samuel Whiting of St. Magnus parish was a freeman of the Fishmongers' Company and was a member of the City of London Livery Companies in 1641. A William Whiting was a freeman of the Blacksmiths' Company. A Joseph, son of Samuel Whiting, attained freeman status in the Fishmonger's Company in 1651. This Samuel Whiting could be the same man who christened 11 childeren in St. Magnus the Martye parish. The researcher searched the records of the Fishmongers' Company. He thought that the William Whiting admitted to the Freedom in 1621 was likely the emigrant and that William was a brother of Samuel (whose family was in St. Magnus parish). The lead led to a search in Stroud, Gloucester. The "Register of Apprenticeship Bindings & Admissions to the Freedom, 1614-1668" for the Fishmongers' Company of London included: 18 June 1621 William Whitinge, late apprentice to John Whitinge, claiming his freedom by service, is admitted and sworne; 15 November 1619 Samuel Whitynge, late apprentice to John Cole, claiming his freedom by service, is admitted and sworne; 29 November 1624 Thomas Whiteinge, son of Thomas Whiting of the Stroude Water in Gloucester, yeoman, put himself apprentice to Thomas Roberts fishmonger for nine years from michaelmas last 1624. The researcher searched Stroud parish (which is incomplete before 1640) and Painswick in Gloucester. He found a William christened in 1622; no Catherine. He studied wills for Whiting testators of the Stroud and Painswick area. Nothing.

22. A John Dumbleton may have been a servant of William Whiting for two years before coming to New England and

then for another 4 or 5 years in New England (History of Windsor, CT pg. 49, 155).

23. Longden's "Northamptonshire and Rutland Clergy" include information about Samuel, son of the John Whiting of Boston, Lincolnshire, who left the 1617 will. The bio for Samuel stated he was the son of John Whiting, merchant of Boston, Lincoln and was christened there on 21 November 1597. Graduated from Emmanuel College at Cambridge. Ordained a priest in 1621 at Peterborough. Served as a minister at Lynn, Norfolk and rector of Skirbeck, Lincoln, in 1625. Went to Boston, New England in April 1636 and then to Lynn, Massachusetts where he was a minister from 1638 to 1679. He died there on 11 December 1679. His eldest son John Whiting was a rector at Leverton, Nottingham. 24. Steven Whiting Hatch stated that "Suffolk Emigrants" declares that the Whiting family came from Suffolk County, England in the vicinity of Basford. (There isn't a parish named Basford in Suffolk, but there is a parish named Boxford. A christening for a William, son of William and Elizabeth Whiting, was found in Aldringham parish dated 9 September 1600.). Holmes' "Dictionary of Ancestral Heads of New England Families" states he came from Boxford, Sussex. (There isn't a parish named Boxford in Sussex but there is a parish named Boxgrove.)

25. Two old undated, unsigned pieces of paper located by Evelyn W. Baird in 1998 while at the Connecticut Historical Society stated that William's wife Susanna was Susanna Wiggins. The researcher did not know the origin of this information.

26. "Whitings in England Before 1650" by Gordon C. Whiting (1978) poses that the most likely place of origin (due to William's nonconformity) is East Anglia (which can include Lincolnshire).

27. Gordon C. Whiting states that Miss M. Packman located the administration of William Whiting's estate in England (1648) and that he left "any and all English property" to his wife. Miss Packman also believes that William could be closely connected to the Whitings of Boxford and Hadleigh in Suffolk or to the Whitings of Boxfor (and Deptford, Kent) in Lincolnshire. Gordon Whiting states that the Whitings of Boston, Lincolnshire loaned money to the colony of Massachusetts. In Gordon's book are listings of Whitings by county that Miss Packman collected. Many are from Lincolnshire and London-two prime areas for William Whiting.

28. A family tree found on FamilyTreeMaker concerning the Descendants of John Whiting states that William Whiting was born in Boxford "Sussex" and died in 1647 in Hartford, Connecticut. His wife Susannah Wiggin was born in 1609 in Milford, Connecticut and married William in 1635 in Hartford. Also claims that William's son William was born in 1631 in Milford, Connecticut and his daughter Sarah was born in 1632 in the same place. This pedigree seems to contain multiple errors and speculation.

- 6. He served as the representative for Connecticut Colony in the king's court. Gov. John Winthrop visited him in London.

- William migrated from England to Cambridge, Massachusetts in 1633 with Thomas Wiggins. Wiggins had been in America before. Another source says that William first came to Cambridge in 1631 and later was an original settler of Hartford (New England Register vol. 103 pg 35).
- 2. An original settler at Hartford in 1636. He came to Hartford with Thomas Hooker, a reverend with the Puritans. Both William Whiting and Thomas Hooker were nonconformists. William was a wealthy merchant dealing with grain from America to England. He had a trading house on the Delaware River and at Westfield and had dealings with Virginia. He owned land in Connecticut and New Hampshire.
- Dep. from Hartford to Connecticut General Court, 1637; a member of the General Court in 1637.
- 4. In 1638 he was allowed to trade with the Indians and in 1642 appointed to collect tribute of the Indians on Long Island and on the mainlands.
- In 1640 William was admitted as a freeman. In 1644 he was listed as a merchant. In 1645 he became the constable in Hartford.
- William served as the second colonial treasurer of Connecticut 1641-1647.
- William was a Major in the colonial forces.
- William served as commissioner of the United Colonies for Connecticut 1646-7.
- William was a leading man in the Connecticut colony and was of a gentleman's status. He was a man of wealth and prominence. His estate at his decease was worth 9000 pounds sterling. He made several trips to England.
- 10. William made his will on 20 March 1643. Codicils were added on 2 April 1646 and on 24 July 1647. (William amended his wills before his voyages at sea to England.) The codicils indicate he had other children since the making of his original will. The will was recorded on 24 April 1649. William named his children as William, John, Samuel, Sarah, Mary, and Joseph. Joseph was likely born after the initial will was made as he was not mentioned in it; he was provided for in a codicil. William had a "sister Wiggins" who had children. He also gave money to Margery Parker, Mr. Hopkins, Mr. Webster, to the children of Mr. Hooker, to the children of Mr. Stone, to the poor of Hartford, to the town of Hartford, to the poor of Windsor, to the poor of Wethersfield. Mrs. Whiting had the will probated on 2 September 1647. William left money to his father and mother (in his 1643 will) if they were still living, and if not, the money was to go to his brother. The parents and brother were not named. On 29 October 1647 Mrs. Susanna (Whiting) Fitch by an instrument of resignation dated 27 June 1662 resigned her interest in the estate of Mr. William Whiting, deceased. On 5 October 1654, Mr. Webster, Mr. Stone, Mr. Fitch, Mr. William Whiting, Mr. John Whiting, presented to the court a distribution of Mr. Whiting's estate agreed upon by them.
- 11. William was a man of weath and education, one of the most respectable settlers in 1636 and one of the civil and religious fathers of Connecticut.
- He was closely associated with George Wyllys and Thomas Wiggin.
- 13. Searches made by James Cunningham in England in 1949 Deptford St. Nicholas, Kent 1592 to 1600 produced

no trace of William Whiting. He did find the marriage of John Whiting and Margaret Bonner on 22 December 1586 in Boston, Lincolnshire. According to the will of this John Whiting, he did not have a son William. The researcher stated that it is possible that the Whiting family was in Boston, Lincoln before the registers began.

- 14. A researcher located in the Bishop of Lincoln probate court a will dated 21 October 1617 (1617, i, folio 239) for John Whiting the elder of Boston, woollendraper. John named a daughter Margarett, wife of Richard Carter; wife Isabell who receives his house in Boston; son James; son Samuel who was at Cambridge; son John; daughter Awdree, wife of Robert Wright. John is the eldest son. His son James is not yet 23. John marked, not signed, the will. Proved on 31 Oct 1617. Witnessed by William Whiting. No son William or daughter Catherine.
- 15. A William Whiting of Boston also left a will dated 1618. He christened a son William at Boston in 1602. The child christened in 1602 cannot be the emigrant because he would have known that his father was dead when he wrote his own will in 1643. However, he could be related. William's 1618 will stated that he was a woollen draper of Boston, had a wife Margaret, youngest son Isaac (minor), son Robert, son William, brother Francis Whiting, and cousins John Whiting and Richard Carter. The researcher assumed that the John Whiting who died in 1617 (the father of the emigrant Samuel Whiting) and the William Whiting who died in 1618/9 were brothers. However, William's 1618 will says that John is his cousin. "There was another brother Francis who may have had children and no doubt there were many other Whitings nearly related. The name occurs frequently in Lincolnshire probate courts." (Letter dated 18 June 1958)
- 16. William Whiting was using a similar coat of arms as John Whiting from Boston, Lincolnshire and John's son, the Reverend Samuel Whiting who migrated to New England and lived at Lynn, Massachusetts. Therefore, there is likely a connection between the ancestral William and these Whiting men of Boston, Lincolnshire. Several letters written by William Jr., his son, are sealed with a coat of arms which are a variation of those used by the family of Whitings of Boston, Lincoln. The coat of arms is described in "Roll of Arms" registered by Committee of Heraldry, New England Historical and Genealogical Society. Major William Whiting, original proprietor of Hartford, liv. 1687 azure a leopard face gold between two flaunches ermine in chief 3 bezants; crest a demi-eagle displayed with two heads proper (New England Register vol. 106 pg. 258). The family's coat or arms were quartered at a Chantry of St. Lawrence at Leake, which is not far from Boston, Lincolnshire. Gordon C. Whiting's book includes a graphic of the coat of arms for Thomas Whiting (1400s) and his descendants in Leicestershire and Essex (page 35). It is very similar to the coat of arms claimed by William Whiting (page 55). See Heraldic Journal, volume 1, pages 61, 160.
- 17. William was possibly living near his sister Catherine in London at the time she married in 1633 and returned to America with her and her husband in 1633.
- 18. Researcher in England found the Whiting surname popular in St. Magnus the Martyr parish in London. But no Catherine Whiting was listed.
- 19. A marriage found for a William and Susan Whiting. "William Whiting of St. Mary Magdalene Canterbury, woolendraper, bachelor, 23, son of William Whiting, Alderman of Canterbury, who consents, and Susan Sabin, virgin, 17, dau of Alvert Sabin, Alderman of Canterbury, who also consents. To marry at St. Mary Bredman's Canterbury." William was christened on 2 April 1615 at St. Mary Magdalene, son of William. He had a sister Katherine christened on 19 Sep 1619. But the William and Susan Whiting who married in Canterbury also christened children in Canterbury down to 1653 and cannot, therefore, be the ancestors who were in America by 1633. (Letter dated 18 June 1958) 20. The 1648 will of James Whiting of Boston, woollen draper was examined. He named his wife Mary, son John (minor), son Samuel (minor), brother Samuel Whiting now in New England, sister Wright, brother John Whiting. So he was the son of the John Whiting who wrote the 1617 will.
- 21. A researcher stated he checked subsidy and assessment lists for London and found a William Whiting living on Thames Street in St. Michael Queenhithe parish in 1638 [but the ancestral William was in New England then]. The researcher thought this could be the ancestor. Another person of interest was Samuel Whiteing of St. Magnus parish which adjoined and was later absorbed with St. Margaret New Fish Street. The registers of St. Michael Queenhithe do not start until October 1653. (Letter dated 27 June 1958) Samuel Whiting of St. Magnus parish was a freeman of the Fishmongers' Company and was a member of the City of London Livery Companies in 1641. A William Whiting was a freeman of the Blacksmiths' Company. A Joseph, son of Samuel Whiting, attained freeman status in the Fishmonger's Company in 1651. This Samuel Whiting could be the same man who christened 11 childeren in St. Magnus the Martye parish. The researcher searched the records of the Fishmongers' Company. He thought that the William Whiting admitted to the Freedom in 1621 was likely the emigrant and that William was a brother of Samuel (whose family was in St. Magnus parish). The lead led to a search in Stroud, Gloucester. The "Register of Apprenticeship Bindings & Admissions to the Freedom, 1614-1668" for the Fishmongers' Company of London included: 18 June 1621 William Whitinge, late apprentice to John Whitinge, claiming his freedom by service, is admitted and sworne; 15 November

1619 Samuel Whitynge, late apprentice to John Cole, claiming his freedom by service, is admitted and sworne; 29 November 1624 Thomas Whiteinge, son of Thomas Whiting of the Stroude Water in Gloucester, yeoman, put himself apprentice to Thomas Roberts fishmonger for nine years from michaelmas last 1624. The researcher searched Stroud parish (which is incomplete before 1640) and Painswick in Gloucester. He found a William christened in 1622; no Catherine. He studied wills for Whiting testators of the Stroud and Painswick area. Nothing.

22. A John Dumbleton may have been a servant of William Whiting for two years before coming to New England and then for another 4 or 5 years in New England (History of Windsor, CT pg. 49, 155).

23. Longden's "Northamptonshire and Rutland Clergy" include information about Samuel, son of the John Whiting of Boston, Lincolnshire, who left the 1617 will. The bio for Samuel stated he was the son of John Whiting, merchant of Boston, Lincoln and was christened there on 21 November 1597. Graduated from Emmanuel College at Cambridge. Ordained a priest in 1621 at Peterborough. Served as a minister at Lynn, Norfolk and rector of Skirbeck, Lincoln, in 1625. Went to Boston, New England in April 1636 and then to Lynn, Massachusetts where he was a minister from 1638 to 1679. He died there on 11 December 1679. His eldest son John Whiting was a rector at Leverton, Nottingham. 24.Steven Whiting Hatch stated that "Suffolk Emigrants" declares that the Whiting family came from Suffolk County, England in the vicinity of Basford. (There isn't a parish named Basford in Suffolk, but there is a parish named Boxford. A christening for a William, son of William and Elizabeth Whiting, was found in Aldringham parish dated 9 September 1600.). Holmes' "Dictionary of Ancestral Heads of New England Families" states he came from Boxford, Sussex. (There isn't a parish named Boxford in Sussex but there is a parish named Boxgrove.)

25. Two old undated, unsigned pieces of paper located by Evelyn W. Baird in 1998 while at the Connecticut Historical Society stated that William's wife Susanna was Susanna Wiggins. The researcher did not know the origin of this information.

26. "Whitings in England Before 1650" by Gordon C. Whiting (1978) poses that the most likely place of origin (due to William's nonconformity) is East Anglia (which can include Lincolnshire).

27. Gordon C. Whiting states that Miss M. Packman located the administration of William Whiting's estate in England (1648) and that he left "any and all English property" to his wife. Miss Packman also believes that William could be closely connected to the Whitings of Boxford and Hadleigh in Suffolk or to the Whitings of Boston (and Deptford, Kent) in Lincolnshire. Gordon Whiting states that the Whitings of Boston, Lincolnshire loaned money to the colony of Massachusetts. In Gordon's book are listings of Whitings by county that Miss Packman collected. Many are from Lincolnshire and London--two prime areas for William Whiting.

28. A family tree found on FamilyTreeMaker concerning the Descendants of John Whiting states that William Whiting was born in Boxford "Sussex" and died in 1647 in Hartford, Connecticut. His wife Susannah Wiggin was born in 1609 in Milford, Connecticut and married William in 1635 in Hartford. Also claims that William's son William was born in 1631 in Milford, Connecticut and his daughter Sarah was born in 1632 in the same place. This pedigree seems to contain multiple errors and speculation.
